I	Direct Observation		
A	Model social skills, relationship-building techniques, and caring behaviors with children and adults.		
B	Acknowledge, validate, and respond to children's needs and emotions.		
C	Use appropriate tone of voice and body language when communicating with both children and adults.		
D	Read stories and show pictures about different emotions.		
E	Ask children meaningful questions about their actions, interests, and feelings.		
F	Encourage children to use their words to resolve conflicts.		
G	Encourage critical thinking, problem solving, and supervised risk taking.		
H	Use "I" statements and describe personal emotions during interactions with children.		
I	Use children's names frequently when talking with them.		
J	Notice and describe prosocial behaviors.		
K	Model flexibility and allow personal mistakes.		
II	Observation or Conversation		
A	Embed opportunities for children to express and discuss their emotions throughout daily routines and events.		
B	Acknowledge children's individual differences in their social-emotional development.		
C	Strengthen relationships with families by considering their preferences and needs when communicating with their children.

II	Observation or Conversation		
D	Use supervision strategies and positive interactions to prevent and address bullying.		
E	Share activities and strategies with families to help children practice social-emotional skills at home.		
F	Model healthy ways of coping with stress and expressing emotions.		
G	Invite families to share their views and experiences.		
H	Ask for help when facing challenges.		
III	Environmental Evidence		
A	Arrange learning environments to promote relationships and social interactions.		
B	Provide an environment that includes and celebrates all children and families.		
C	Provide areas where children can relax, sit, and observe the activities in the classroom or program space.		
D	Offer a variety of sensory materials.		
E	Provide puppets or stuffed animals for young children to role play situations in which they are experiencing strong emotions.		
F	Provide time in daily schedule for children to play in an unstructured, relaxed way.		
G	Select toys and materials and plan activities that encourage children to work together in groups with other children of varied backgrounds and capabilities.
